- **Resolution-08:** The expenditure amounting of Rs 2,36,772/-towards the third convocation of Children's University held on 29.10.2022 at Indian Institute of Teachers Education Campus was approved. The Members of finance committee were thankful to the officers and authorities of IITE, Gandhinagar to bear remaining expenditure of convocation of Children's University.
- Agenda-09: The Expenditure amounting of Rs.2,09,546/-towards the National Seminar on Holistic Child Development in Early Years: Concern, Challenges and Pathways sponsored by Indian Council of Social Science Research (ICSSR) New Delhi was put up for approval. (Annexure-10) (Centre of Research)
- Resolution-09: The approximate Expenditure amounting of Rs.2,09,546/-towards the National Seminar on Holistic Child Development in Early Years: Concern, Challenges and Pathways sponsored by Indian Council of Social Science Research (ICSSR) New Delhi was approved.
- Agenda-10: The matter is put up for decision to hire the service of Architect Shri Harit Padiyar and his service charge as a consultant as he has carried out the work as a consultant initially from the construction work of Toy House without deciding fees and hiring of his service. And the matter of rate of consultancy fees of Kakani Association, Architect appointed for Shahpur New building construction. (Annexure-11) (Estate Branch)
- Resolution-10: It was resolved that the Service of Shri Harit Padhiyar, Architect & Interior Designer for Architectural consultancy services is deemed to be considered as hired by the University from initial stage. Moreover, his consultancy fee was Rs.6,00,000/- as demanded in his letter dated 21/12/2022 which scaled down to Rs.5,00,000/- (including all taxes) after negotiation.

As per the letter dated 5/10/2022, the rate of consultancy fee of Kakani Association, Architect appointed for Shahpur New building construction was demanded 2.35 % of a total project cost. Although, it was decided 2.20% (including all taxes) after negotiation.
