- 3. Candidates qualified with UGC-NET/JRF/CSIR/GSET are exempted from CRU Ph.D. Entrance Examination. The validity for the UGC-NET/JRF/CSIR/GSET certificate is for One year from the date of issuance of the certificate.
- 4. Master's Degree in the relevant subject with 55 % marks is essential. (Relaxation applicable as per UGC Norms to reserved category students).
- 5. Students are required to get verified the Ph.D. application form with original documents. Without verification application form will not be considered.
- 6. Students are required to visit University website regularly. No correspondence will be entertained regarding this.

### **General Instructions**

- 1. The candidates must read the conditions of eligibility as given in Notification carefully and must satisfy themselves regarding their eligibility for the admission before filling the application form.
- 2. The candidate must register for Ph.D. admission through online GCAS registration portal Click on: <a href="https://gcas.gujgov.edu.in">https://gcas.gujgov.edu.in</a>. The candidates are advised to refer to the user manual for online registration on the GCAS portal.
- 3. The candidates must check the availability for the subject for which they want to apply.
- 4. The candidates seek to admission for Ph.D. shall be required to have a minimum of 55% score under any evaluation system at the Master's level in the subject respective. A relaxation of 5% marks or its equivalent grade may be allowed for those belonging to SC/ST/SEBC (non-creamy layer)/Differently-Abled and Economically Weaker Section (EWS) of the candidates having domicile of Gujarat State.
- 5. Candidates having UGC- NET / NET JRF / UGC –CSIR NET / GSET will have to apply under Non Entrance Test Category.
- 6. The candidates who hold UGC NET/GSET certificate for Assistant Professor and Ph.D. Admission shall be valid for one Year from the date of Issuance of Certificate and Notification date of this Ph.D. Notification for Ph.D. Admission programme where as the Candidate of UGC NET with JRF stands permanent validity for Ph.D. Admission.
- 7. Only Application Form filled up by the candidate through GCAS portal shall be considered valid.
- 8. The Online Application form Fee can be remitted through Online payment only through GCAS portal. The Application fee shall not be refunded in any case. The candidate will have to pay Rs. 1000/- for Ph.D. Entrance Test at Children's Research University through the link as given below. www/cugujarat.ac.in/admission It is compulsory for the Ph.D. Entrance Test category students to pay the Ph.D.
  - It is compulsory for the Ph.D. Entrance Test category students to pay the Ph.D. Entrance Test fee. The fee once paid at the Children' Research University cannot be refunded at any point of time.
- 9. The candidates in their own interest are requested to retain a photocopy of the Application Form and Fee Receipt for record.

- 10. The hard copy of online application form duly completed in all respect (along with all educational mark sheets and other required documents) should be verified and submitted in person at Children's Research University on the date Group Discussion and Personal Interviews (GDPI) after qualifying CRU PET Examination. If the documents are not satisfactory or found false, the admission shall be treated cancelled.
- 11. The University reserves the rights to increase or decrease vacant seats for admission without prior notice.
- 12. Canvassing in any form by the candidate or on behalf of any candidate will disqualify the candidate.
- 13.A candidate who is qualified for Ph.D. admission has to submit and present his/her research proposal at the time of GDPI.
- 14. The full time scholars are required to work on regular basis for entire Ph.D. programme in their respective departments or place of assignment by their Research Supervisors/University. The scholars who are receiving assistantship/scholarship/fellowship from UGC/ICSSR, Industry or any other funding agency as RA/SRF/JRF/Project Fellow of CRU shall be considered as full time scholars provided they submit the fellowship certificate/award letter from the authority concerned. In such cases the status report shall be submitted to RDC.
- 15.A "No Objection Certificate" is mandatory from the Head of the institution/employer along with the application for the candidates who opt for Part Time Ph.D. Category. Such scholars shall not be entitled/eligible for any kind of fellowship, financial assistantship and accommodation offered by the University. The No Objection Certificate shall clearly stating that:
  - [i] The candidate is permitted to pursue studies on a part-time basis.
  - [ii] His/her official duties permit him/her to devote sufficient time for research.
  - [iii] If required, he/she will be relieved from the duty to complete the course work.
- 16.A candidate who is selected for Ph.D. admission has to complete Ph.D. course work as per university Ph.D. Ordinance-2024 and UGC rules from time to time.
- 17.No candidate shall be allowed to register simultaneously for any other course after registering for Ph. D. If, at any point of time, it is found to be otherwise, his/her admission shall ipso facto stand cancelled, and all the fees and deposits paid by the candidate shall stand forfeited.
- 18. The applicants shall have to visit the cugujarat.ac.in website regularly for the updates regarding Ph.D. Admissions.

- 19.Any relaxation to the reserved category students will be applicable as per reservation rules of Government of Gujarat. The candidates applying under the reserved categories shall submit the valid Category Certificates (SC/ST/SEBC Non-Creamy Layer Certificate/EWS/ Differently abled) issued by the competent authority in the prescribed format at the time of Application and should be submitted during the verification process on the date of GDPI.
- 20. The CRU PET exam for the Entrance Category candidates shall be MCQ based Paper Pen Test in person. The candidate will have to secure minimum 50% marks to qualify the CRU PET and the candidates of reserved category shall be provided 5% relaxation to qualify the exam. The venue, date and time shall also be declared on the university website.
- 21. The aspirant candidates shall not be provided any TA/DA or other allowance for CRU PET Exam and GDPI.
- 22.In case of any dispute, the CRU Ph.D.Ordinance-2024, UGC Ph.D. Regulations-2022 and the decision of the Hon'ble Vice-Chancellor shall be final.
- 23. The waiting list shall be operated on account of the shortlisted candidates who don't pay the First term fee within 10 days of the publication of the Shortlisted candidates list. The waiting list shall be operated for the 30 days from the publication of the first list of the shortlisted candidates.

### Terms and Conditions for Ph.D. Admissions

- 1. If the Entrance Category candidate remains absent during the CRU Ph.D. Entrance Test, his/her admission shall be cancelled. CRU PET shall not be conducted again/separately.
- 2. If the candidate after qualifying Ph.D. Entrance Test remains absent in the GDPI, his/her admission shall be treated as cancelled and no request shall be accepted for the reschedule of the GDPI.
- 3. Validity for the CRU Ph.D. Entrance Test shall stand for this particular Advertisement Notification (July 2024) only.
- 4. Non Entrance Category students (NET/GSET) will have to appear for the GDPI as and when schedule to claim for admission.
- 5. The Ph.D. Research Proposal presentation during the GDPI should be exclusively Child Centric Research.
- 6. The Syllabus for the Ph.D. Entrance Test for Paper-I Research Methodology and for Paper-II as per relevant Post Graduation Subject Specialization.
- 7. The OUG, OUT students should hold the PG degrees from the UGC recognized University.
- 8. If at any point of time, the candidate fails to pay the First Term Fees (with Registration Fee) in the given duration, his/her admission shall be cancelled and the Next candidate shall be invited for the further admission process.
- 9. The students who studied in India and migrate to abroad will have to follow all the university prescribed rules and regulations for Full Time and Part Time students.
- 10.If the candidate of reservation category fails to produce the valid reservation category certificate, his/her admission shall stand cancelled.
- 11. The selected research topics for the Ph.D. progrmme must be relevant to the Child Centric Research and must fulfil the objectives of the Children's Research University, Gandhinagar. The Research Development Committee (RDC) of the University may modify and approve the research topics.
- 12.At any point of time, the University is empowered to add/alter/change the terms and conditions of Ph.D.
