MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (MoU) is made on 29/04/2023.

Between

Children's University, Subhash Chandra Bose Shikshan Sankul, Sector-20, Gandhinagar-382021(Gujarat), India. (Hereinafter referred to as CU).

&

Ministry of Women and Child Development, New Delhi, India.

1. Objective

The goal for this MoU is to foster collaboration, provide opportunity for global experience and to facilitate advancement of knowledge on the basis of reciprocity, best efforts, mutual benefits, and frequent interactions. CU and Ministry of Women and Child Development, New Delhi, India agree:

- a. To provide advanced Centres of learning, where Anganwadi Workers, Elementary Education Teachers, Child Care & Protection duty holders, scholars and students would enrich and advance studies and research to understand assess, disseminate and implementation of ideas and thoughts of Gijubhai Badheka.
- b. To engage in research and in turn contribute to the advancement of knowledge in the area of the study particularly in the discipline of Elementary Education, Holistic Child Development, Language, Child Rights, Philosophy, Human Rights, Sociology, Social Work, Law, and other disciplines.
- c. To publish the outcome of the research studies in form of scholarly articles in the peer- reviewed indexed journals from the UGC-CARE list and also as books published by the reputed national and international publishers having strong peer-reviewed policy.
- d. To develop appropriate methodologies to translate and transmit Gijubhai Badheka's ideas of elementary education and holistic development of children into practical propositions and policy instruments.
- e. the Chair Professor to be appointed within a period of 6 months
- f. plan of action to be prepared and submitted by Chair Professor
- g. CU to create exclusive web page showing activities and achievements of Chair Professor
- h. CU to evolve mechanism to review progress of Chair annually. UC/SoE to be submitted for facilitating release.
- i. CU to submit final report on the activities and outcome of the Chair, etc.

2. Financial Arrangements

Ministry of Women and Child Development will financially support initiatives under this MoU. In addition, both parties understand that all

financial arrangements between the parties have to be further negotiated and mutually agreed, and will depend on the availability of funds.

4. Intellectual Property

Ministry of Women and Child Development & CU agree to respect each other's rights to intellectual property. Further, the intellectual property



rights that arise, as a result of any collaborative research or activity under this MoU will be worked out on a case-to-case basis, and will be consistent with the officially laid down IPR policies of the two institutions.

5. Legal Relationship

This MoU shall be construed as a statement of purpose to promote a genuine and mutually beneficial collaboration between the parties. Nothing in this MoU shall create any legal relationship between the parties. Should there be a dispute relating to any aspect of academic cooperation, Ministry of Women and Child Development, New Delhi, India & CU will jointly resolve the dispute in a spirit of independence, mutual respect and shared responsibility.

6. Commencement, Renewal & Termination

This MoU will be effective from the date of the last signature hereto and will remain in force for a time period of Five (05) years, with a possibility for renewal at the end of the Five year-period, subject to the parties' written agreement.

Either party may terminate this MoU by giving three (3) months' notice in writing to the other party.
